



## Pain Society of Alberta – Digital Conference Passport OFFICIAL CONTEST RULES

- 1. Eligibility:** Contests are applicable to participants of the PSA World Pain Summit (Pain Society of Alberta) Virtual Conference who are 18 as of the date of entry. There is no cost to play. Participants who are residents in Quebec, Canada are not eligible to participate in the contests. Employees and members of the PSA, the Contest Planning Committee Members and any parties engaged in the development, production or distribution of the contest, and those living in the same household are not eligible. The contests are subject to all applicable federal, provincial, and local laws and regulations. Participants who are resident in a jurisdiction that is outside of Canada confirm that participation in the Contest is permitted by the laws, rules and regulations applicable to the participant and such participant's jurisdiction of residence. The PSA reserves the right to void or disqualify any contest participation or win if advisable and/or required by applicable laws.

Contest winners who reside outside of Canada may be required to provide additional assurances that participation in the Contest has complied with the rules and regulations of the jurisdiction of residence. The PSA reserves the right to request additional information as considered necessary to determine eligibility, refusal to provide the necessary information may result in disqualification. Winners of the PSA Digital Conference Passport will be required to provide government issued photo identification suitable to the Board of Directors to ensure compliance with the age and residency restrictions. Failure to follow this contest rule may cause disqualification and another potential winner will be chosen.

- 2. Agreement to Rules:** By participating, you represent and warrant that you have read the rules and meet the eligibility requirements. In addition, you agree to accept the decisions as final and binding as it relates to the content of this contest.
- 3. Contest Period:** The contests begin on Friday October 15, 2021 at 0800h(MDT) and all entries must be received by Sunday October 17, 2021 at 1500h (MDT) , specified on our Facebook post, Twitter tweet, or announced by a PSA member during the broadcast.
- 4. How to Enter:** Participants must answer all of the questions through the link provided by the PSA and enter their responses by submitting. Receipt of entry occurs when PSA's server records the submission. The entry must fulfill all contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the PSA. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
- 5. Prizes:** There are ten prizes available to be won as follows;

6. The Winner(s) of the contests (the “Winner”) will receive the prize as specified and must accept it to be won. The prizes have no redeemable cash value and no cash or other prize substitution shall be permitted. Prizes or any portion of a prize cannot be combined with other discounts, promotions or special offers. PSA reserves the right to substitute an alternate prize of equal or greater value if an advertised prize is unavailable at the time of award. All winners assume any and all liability for any injury or damage caused, or claimed to be caused, by entering, participating in the Contests or the use or redemption of a prize. One digital passport will be used solely for healthcare providers and separate one for non-healthcare providers, however there is only one Contest and only five prizes that will be dispersed and awarded amongst both groups.
7. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, provincial, and/or local taxes, duties, brokerage, shipping and handling, shall be the sole responsibility of Winner. Acceptance of prize constitutes permission for the Pain Society of Alberta to use the Winner’s name and likeness on the Pain Society of Alberta website without further compensation, unless prohibited by law.
8. **Odds of Winning.** The odds of winning depend on the number of eligible entries received before the Contest end date.
9. **Winner Selection and Notification:** Within 5 business days of Sunday October 17, 2021, the PSA or an employee, agent or other representative of the PSA will conduct a random draw from all eligible and complete entries and select the potential winners (Selected Entrants). Selected Entrants will be deemed winners if they meet all eligibility criteria set out in these contest rules. If a Selected Entrant does not meet the eligibility criteria, he/she will be disqualified and will not receive a prize and another entrant will be selected by way of random draw from remaining eligible entries. Before being declared a winner, Selected Entrants will be required to: (i) have completed and accurately answered each question submitted on the contest link; (ii) sign and return the Declaration of Eligibility and Liability/ Publicity Release Form (Winner Release); and (iii) comply with all other contest rules.

Selected Entrants will be notified within five business days of the contest draw and will be contacted via email that was provided at the time of entry into the contest. Registrants who have not entered their full name and correct email address will be disqualified. Up to three attempts will be made to contact the Selected Entrants within 10 business days following the draw. A Selected Entrant that does not or cannot accept a prize may be forfeited and a new Selected Entrant selected by random draw, at PSA’s sole discretion. As signed copy of the Winner’s Release must be received by PSA before PSA will release the Prize. PSA is not responsible for the failure for any reason whatsoever of a Selected Entrant to receive notification or for PSA to receive a Selected Entrant’s response.

Receipt by a Selected Entrant of the prize offered in this contest is conditioned upon compliance with any and all federal, provincial, and local laws and regulations.

Disputes regarding identity of entrant: If the identity of a Selected Entrant is disputed, the entry will be deemed to have been submitted by the individual assigned to the email address entered at the time of entry. Each Selected Entrant may be required to provide proof that he/she is the authorized account holder associated with a selected entry.

**10. Release and Indemnification:** All winners must sign the Winner Release to: (i) confirm compliance with all Contest Rules; (ii) agree to accept prizes as awarded; (iii) release, discharge and hold harmless PSA, its departments and agencies, parent, related and affiliated companies, subsidiaries, franchisees, advertising and promotional agencies, counsel, marketing partners, and each of their respective directors, officers, employees, members, successors, sponsors, partners, licensees, subsidiaries, agents, artists, advisors, assignees, and all others associated with the administration, development and execution of the Contest (Released Parties) from and against any and all manner of action, cause of action, claim or demand, loss or injury, use or misuse of a prize or any travel related thereto, and the use of entries by PSA, suit, debt, covenant, contract, including legal fees and expenses, whatsoever, including but not limited to, claims based on negligence, breach of contract and fundamental breach, failure of any third-party contractor or supplier used in connection with any aspect of the Contest to perform or deliver any goods or services, any act of God or any other event beyond the Released Parties' control, any dissatisfaction of any kind by a winner with any aspect of the Contest or any prize, liability for physical injury, death, or property damage which the entrants, guests, their heirs, successors or assigns have, might have or could have suffered, by reason of or arising out of the entrant's participation in the Contest and/or in connection with the acceptance and/or exercise by the entrant of prizes as awarded; and (iv) indemnify the Released Parties against any loss, damage or expense, including legal fees, that any of the Released Parties may suffer or incur as a result of any non-compliance by entrants with any of the Contest Rules or participation in the Contest and/or in connection with the acceptance and/or exercise by an entrant of a prize, and the use of entries by PSA.

- 11. Other Conditions:** PSA reserves the right to terminate or amend this Contest at any time and in any way, without prior notice to entrants. Without limiting the foregoing, if, for any reason, the Contest is not capable of running as originally planned for any reason, PSA reserves the right to cancel the Contest and conduct a random draw from all previously received eligible entries received by the Contest end date.
- 12. Publicity and Entrant Information.** By participating in the Contest, entrants' consent to the use of their name, address, email address, postal code, telephone number, social media handle(s), comments and image, whether on videotape, photograph or any other means, for the administration of the Contest or any publicity carried out by PSA, without further notice or compensation.
- 13. Law.** The Contest is void where prohibited by law and is subject to all applicable Canadian federal, provincial, territorial, municipal and local laws. This Contest shall be governed exclusively by the laws of the province of Alberta, Canada, including all issues and questions concerning the construction, validity, interpretation and enforceability of these Contest rules, rights and obligations between entrants and PSA, and procedural provisions, without giving effect to any choice of law or conflict of law rules. Any dispute shall be adjudicated by the courts sitting in the city of Calgary in the province of Alberta.
- 14. Rule Amendments:** PSA reserves the right, in its sole discretion, to amend or modify these Contest Rules, or modify, cancel or suspend this Contest, without prior notice for any reason whatsoever, including without limitation in the event that any cause beyond the reasonable control of PSA corrupts, or threatens to corrupt, the security or proper administration of the Contest.
- 15. Intellectual Property:** All intellectual property, including but not limited to trademarks, logos, designs, promotional materials, web pages, source codes, images, drawings, illustrations, slogans and representations are owned by PSA. All rights reserved. Unauthorized copying or use of any of the PSA's intellectual property without the express written consent of PSA is strictly prohibited.
